

**CITY OF STRUTHERS**  
**Ordinance**

**AN ORDINANCE CREATING THE POSITION OF TWO PART-TIME  
TAX CLERKS IN THE TAX OFFICE, SETTING THE HOURS AND  
WAGES FOR SAID POSITIONS, REPEALING ORDINANCE NO. 19-  
033, AND ANY ORDINANCE INCONSISTENT HEREWITH AND  
DECLARING AN EMERGENCY.**

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the City of Struthers, Ohio,  $\frac{3}{4}$ 's of all members elected thereto concurring:

**SECTION 1:** That the Council of the City of Struthers, Ohio hereby creates the position of two part-time Tax Clerks in the Tax Office. The part-time Deputy Tax Commissioner shall receive an hourly rate of \$15.94 per hour. The part-time Tax Clerk shall receive an hourly rate of \$11.22 per hour during their first twelve months of service.

**SECTION 2:** Said part-time Deputy Tax Commissioner and part-time Tax Clerk in the Tax Office shall be appointed by the Mayor. Schedule to be regulated by the Tax Commissioner.

**SECTION 3:** Said scheduled hours shall not exceed twenty-eight (28).

**SECTION 4:** It is understood that said person is eligible for no fringe benefits and shall work an average of twenty-eight (28) hours per week, not to exceed one thousand four hundred fifty six (1,456) hours per calendar year. It is further stated that conditions of employment shall be explained to each applicant.

**SECTION 5:** That this Ordinance is retroactive to January 1, 2020.

**SECTION 6:** That ordinance No. 19-033 and any ordinance inconsistent herewith are hereby repealed.

**SECTION 7:** This ordinance is hereby declared to be an emergency measure necessary for the preservation of public peace, health and safety of the inhabitants of the City of Struthers, Ohio. Said emergency exists by reason of the fact and part-time employees get paid, as such, this ordinance shall take effect upon its passage and approval by the Mayor.
