AN ORDINANCE AUTHORIZING THE MAYOR AND SAFETY SERVICE DIRECTOR TO ENTER INTO AN AMENDMENT #1 TO THE AGREEMENT BETWEEN THE CITY AND ENVIRONMENTAL DESIGN GROUP NO. 24-00315-01P FOR ENGINEERING SERVICES FOR MAH-WETMORE DRIVE BRIDGE REPLACEMENT, PID 118677, RETO ACTIVE TO JULY 1, 2024, REPEALING ORDINANCE NO. 24-054 AND ANY ORDINANCE INCONSISTANT AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Struthers, Ohio, $\frac{3}{4}$'s of all members elected thereto concurring:

SECTION 1: That the Mayor and Safety Service Director are hereby authorized to enter into an amendment # 1 to the agreement between the City and Environmental Design Group for engineering services for MAH-Wetmore Drive Bridge Replacement, PID 118677.

SECTION 2: A copy of said Amendment is marked Exhibit "A" and attached hereto and made a part thereof.

SECTION 3: Payment for said engineering services when needed shall not exceed \$113,432.00 and shall be expended from the 2024 General Fund Budget Categories 215 Street Resurfacing, 510 Storm Water and 210 Permissive Auto.

SECTION 4: That Ordinance No. 24-054 and any ordinance inconsistent herewith are hereby repealed.


SECTION 5: That this Ordinance effective date is retroactive to July 1, 2024.


SECTION 6: That it is FOUND and DETERMINED that all formal actions of this Council relating to the passage of this Resolution or adopted in an open meeting of this Council, and that all deliberations of this Council, and of any of its committees which resulted in such formal actions were made in compliance with all legal requirements, including those of section 121.22 of the Ohio Revised Code.

SECTION 7: That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of public peace and the health and safety of the inhabitants of the City of Struthers, Ohio. Said emergency exists by reason of the fact that engineering services are needed immediately, and, as such, this Ordinance shall take effect upon its passage and approval by the Mayor.


