### **ADDRESSING OF COUNCIL (On Audio)**

**(On Audio - These minutes are a summarization of the Regular Meeting and not verbatim.)**

Mr. Robert (Bob) Carcelli, 409 Edison Street, Struthers, Ohio 44471. He stated to Mr. Patrick that he is glad to see him get things moving with regards to Occupancy and Landlord Ordinances. When did you say the meeting was going to be?

#### **Comments/Remarks:**

Mr. Michael S. Patrick answered Mr. Carcelli saying the meeting will be Wednesday, May 15, 2019. He stated that he will have Maureen O'Neil down here to talk about the process how Campbell handles their Landlord Ordinance and give an over view how it can work for the City of Struthers.

Mr. Bob Carcelli asked that once you get all your recommendations do you plan on turning that information over to the Law Director.

Mr. Michael S. Patrick stated that he has already been briefed on this information.

Mr. Bob Carcelli stated that he is the one that will help build the Ordinance.

Mr. Michael S. Patrick stated that the Ordinance has already been built and been through his office, as well as, the inspection form. He stated that this meeting is for the Administrative side of the Ordinance. He said that Maureen O'Neil will be coming down here to talk with Council on what she proposes for our City. She runs the City of Campbell's program and does very well there. He stated that she said that a person for our City probable can put in 15 hours per week. She proposed three things for our City: 1) She can take on our City for 15 hours per week, 2) She can train somebody to do the job, and 3) City can hire someone off the street to take on the position to run the Landlord program. He told Bob that we are going to look at her recommendations and go from there. He spoke at length on the matter.

Mr. Bob Carcelli asked Mr. Patrick if he thought 15 hours per week is suitable for our City, with the condition of the way our town looks. He said you are taking the recommendation of a Campbell resident and taking care of Campbell? You better go look in Campbell? That's number one! He said that he has only so many minutes...

Mr. Patrick stated that is what Ms. O'Neil recommended. She is specialized in this field.

Mr. Bob Carcelli stated that he has never heard of a 3 minute time limit given to resident to speak and address council.

President of Council, Henry D. Franceschelli, Sr. stated that we have an ordinance and that he can set the time. I can set the time at the beginning of the meetings. I set the time to three minutes. Megan will get the ordinance, if you want to see it.

Mr. Bob Carcelli stated that the matter of dealing with CASTLO. I am very happy to see finally someone able to get back to me about how many jobs are in CASTLO, but I would like to know how many companies each one of those jobs can file? Not just there are hundred and some jobs.

President of Council, Henry D. Franceschelli, Sr. stated that Mr. Bigley will look that up too.

Mr. Dallas Bigley stated that he already answered his questions. He stated that there are ten (10) businesses in CASTLO and 140 employees.

Mr. Bob Carcelli stated why don't you give that to me in writing.

Mr. Bigley stated that he gave him the information and that he can write it down. You are more than welcome to write the information down.

Mr. Carcelli stated give that to me in writing.

Mr. Bigley said write it down.

Mr. Carcelli said no you write it down. Give it to me in writing.

Mr. Bigley said that he just explained it to him.

Mr. Carcelli stated that you are here to serve me.
