The Regular Meeting of the Council of the City of Struthers, Ohio, was held on Wednesday, April 22, 2020 at 7:00 p.m. in Council Chambers with the following members present at Roll Call: Baluck, Bayus, Bigley, Burnside, Carcelli, Greenwood, Pingley.

President of Council, Joseph N. Rudzik was present at the Meeting.

President of Council, Joseph N. Rudzik asked everyone to stand for the Pledge.

Pledge was recited.

President of Council, Joseph N. Rudzik thanked everyone for coming this evening.

President of Council, Joseph N. Rudzik recognized the invited guest in attendance at the Regular Council Meeting: Mayor Catherine Cercone Miller, Safety Service Director, Tim Daley, and Auditor, Christina Bohl. (Law Director, John N. Zomoida Jr., Tax Commissioner, Ryan Rogalski, Judge Dominic Leone and Treasurer, Robert D. Carcelli, III—not present.).

President of Council, Joseph N. Rudzik, asked for a motion to dispense with the reading of the minutes of 1<sup>st</sup> Regular Meeting dated Wednesday, March 25, 2020 and to accept the minutes. Do I have a motion? A second?

Carcelli moved seconded by Bigley to dispense with the reading of the minutes of 2<sup>nd</sup> Regular Meeting dated March 25, 2020 and accept them as prepared by the Clerk. Roll Call: Voting yea: Baluck, Bayus, Bigley, Burnside, Carcelli, Greenwood, Pingley. Motion carried 7-0.

Meeting minutes accepted by 7-0 vote.

President of Council, Joseph N. Rudzik, asked the clerk to read the (7) seven pieces of communications.

**Remarks/Comments: (On Audio)**

Mr. Ronald A. Carcelli thanked Mr. John N. Zomoida for communication #1. He thanked John for sending said letter to Miss. Debra Sevi, 596 Sexton Street. He made everyone aware that they are still working on cars at that address to this day. Also, the neighbor to Miss. Sevi has a vehicle parked in the front yard. The Mayor knows this because she sent the police up there to cite them for having the vehicle parked in the front yard. That has to be stopped.

Mr. Bigley stated that he has been called on a lot of property code violations and I know this is a tough time with COVID-19 but we really still need to focus on these violations because a lot of residents are upset as they should be. We have ordinances on the books that need to be enforced. There is no reason to have ordinances if they are not ever going to be enforced.

Miss. Megan L. Pingley stated that she has had many complaints as well.

Mr. James E. Baluck stated that communication #1 was sent to the owner of the Sexton Street property and not the tenant living there. They are renting and I believe that Sevi is the last name of the owner of said property. I believe these renters probably never received the letter. Maybe the letter needs to be addressed with the people that are living there because the owner may never bother telling tenants.

Mr. Joseph N. Rudzik stated that the Mayor did send the Police up there so I am assuming that they do know what they are in violation of. Is that correct Mayor?

Mr. Dallas A. Bigely made additional comments speaking to Mr. James E. Baluck. They had back and forth dialogue regarding this matter.

Mayor Cat Cercone Miller asked to speak. She stated that this property is something that we have been dealing with for a while now for the last couple of weeks. We have had Officers there and the residents have been cited on multiple occasions. We did send the letter out and it did say that they are the owners of the property and we are hoping that they rectify the situation. We can't cite the residents; we have to cite the property owner for it. Once we are able to cite the property owner then whatever they do it is on them, but once we get something in court and cite them for a misdemeanor that just keeps elevating. We have to have piece there first and the fines just keep increasing with each citation. Mayor Miller spoke at length explaining how it works in the court with the citations and how the cops are supposed to be looking for other things to help with increasing the misdemeanor to an m1, m2, and m3. She went on to say that property code violations, Tim Daley has been on it. She stated that we probably have a stack over a foot tall of all property code violations that people have complied since January. She stated that it's not that he isn't doing anything. If you all still have complaints put them in the mail slot for Tim or give Tim a call. He is still handling them and taking calls from the Mayor's Office.

Mr. Dallas A. Bigley stated that it's not solely Tim's job to do the property code enforcement. It is also the Police's job as well. So when I say that things need enforced so I am not directing that solely at the Safety Service Director. The Safety Service Director has many different functions, but if you have officers that are driving up and down the street on a daily basis and see cars parked in the front yard. Then they need to stop and they should ticket those residents. No one needs to send a letter those are ticket able offences that need and should be done.

Mayor Cat Cercone Miller stated that she 100% agrees with what Dallas was saying and stated that she is working with Chief Roddy and Safety Service Director to figure out the best way of dealing with all this because Captain Pat Bundy was the sole officer that use to do property code violations, but since his retirement they are having a little bite of trouble. She stated that this is something we are on top of as well.

Mr. Robert D. Burnside stated he is in agreement with Mr. Bigley. He believes enforcing the Police to do their job, but it is also a good plan to have a paper trail like the Mayor Said to have more teeth in what they are violating as well.

Mayor Miller stated that with everything going on the court is not dealing with and processing. She went on further to say, I know that they are not looking at the housing code violations. Even though we are turning them in they are not processing them right now. They are on hold because they are only dealing with more serve cases not that these aren't important it is just not a priority right now. They will get processed just not right now.

Mr. James E. Baluck stated that the actual home owner can be fined and cited for this as well.

Mayor Miller stated yes. When we send letters out they go to residence and the property owner. The resident should be receiving a copy of the letter as well.

Mr. James Baluck stated very good. Thank you!

## **ANYONE WISHING TO ADDRESS COUNCIL ON PENDING LEGISLATION**

### **Comments/Remarks: (On Audio)**

Mr. Dallas A. Bigley stated that legislation #1 about the MOU's is a good thing and wanted the Mayor to elaborate on it, if she is able to.

Mayor Millere stated that this for us to be able to combat the Coronavirus Response Act through the Federal Government. She stated that she has been in contact with Mike Esposito with Clemens & Nelson a lot and he was advising that we go through MOU's with each Union basically giving them 80 hours of paid administrator leave time so if we tell someone to self-quarantine and they are home for two weeks so if they contract the virus or their spouse contracts the virus there are allowed to be given 80 hours of paid administrative leave. This will also extend to our employees not with a Bargaining Unit, so that way we tell them to go home and self-quarantine for 2 weeks then they will be paid and they would not have to dip into their sick-time. This is something that many cities have agreed to have their first responders into the Response Act. She felt strongly about this and glad that nothing has become of those that have had to use this already. She spoke at length on the matter further.

Mr. Dallas A. Bigley stated that he thought that was a great idea honestly. I know that this is a bad time but I think this is a plus.

Mayor Cat stated thank you Council!

#### **Remarks/Comments:**

Mr. Ronald A. Carcelli stated that the Tax Department for the month of January/February shows that we were up but in March it shows us down. Is that correct?

Auditor Bohl said yes. She said over all I think Ryan has us down 34%, should you look at his Report for the month of March. She said that it looks like 22% for the whole year. As you know that we extended the Tax deadline to July, so I don't think going forward I don't think we are going to be able to compare month to month and get a realistic idea because the Tax deadline is not April.

Mr. Ronald A. Carcelli stated that if we don't get a Tax pick up in July a good amount of money in July then we are going to have problems.

Safety Service Director was present at the meeting and had no report for Council this evening.

#### **Remarks/Comments:**

Mr. Robert D. Burnside asked Tim if the Street Department has an Orange Sweeper? He stated that when they started sweeping in Nebo they used an Orange Street Sweeper.

Mr. Thomas Daley stated that yes we have an orange sweeper that was a loaner from the company that we are purchasing one from and they gave us a loaner until the end of the month.

Mr. Robert D. Burnside stated that it did a terrible job on his street with that Street Sweeper. There is still all kinds of stuff on the Street that needs picked up.

Mr. Daley stated that he will have that taken care of. Thank you!

Mr. Robert D. Burnside said Thank you!

Mr. Ronald A. Carcelli, 535 Wilson Street, that house has been burned and he wants to put Mr. Daley on notice that the house needs to be torn down. Also, have another house that I am sure others are complaining about it is the house on Sexton/Dogwood. He stated that he was there to look at the address but there was no address not sure if it was burned off or what but I am sure you know which one I am talking about.

Mr. Thomas Daley stated the one that was on fire.

Miss. Megan L. Pingley, 344 Sexton Street, stated that there have been windows boarded up on that house for probably over a year and the business on the corner of Sexton/Fifth keeps calling me and asking if anything that can be done about that and I guess they have been dumping their trash in the business's dumpster also. Can anything be done with the boarded up windows on that house?

Mr. Thomas Daley said that he can send them a letter.

Miss. Megan L. Pingley said Thank You!

Mr. Daley said that he will check but he is sure that that was already sent.

Mr. Dallas A. Bigley said Megan if they continue with placing their trash into the Business dumpster that is a criminal matter.

Miss. Megan L. Pingley said Thank You, Dallas!

Mr. Richard S. Bayus commended Mr. Daley for going up to the house on Brandon Street with the trailer and all that trash in his driveway. He keeps blowing him off a little bit but with COVID-19 and everybody else doesn't believe that it will go through court but it is still making our City look bad. He stated it is just not this property but everyone is taking advantage of this situation here in the City. Also, not sure who owns the property between CVS and those yards behind that business, but that property needs cleaned up with all that trash back there.

Mr. Thomas Daley stated that he will check on that and said that they normally would get the court workers to do all that but that has all been suspended.



Mr. Richard Bayus stated that he wanted to bring that to his attention.

Mr. Dallas A. Bigley stated that he received a call from Mr. Basista on Rocklyedge where Rocklyedge and Lakeshore meet. There is an inlet there and storm water comes out into Hamilton. He stated that there is a bunch of trash that has collected there especially when it storms. I know that is Aqua Ohio property, but because it comes from storm water into there do we have any bearing on getting that cleaned up or is that solely up to Aqua .

Mr. Thomas Daley stated that would be the property owner Aqua. If it's private property we can't do it.

Mr. Dallas A. Bigley said Thank you! I just didn't know if we had any liability because it went through our storm water to go there that is all.

Mr. Daley stated that he will take a look at it.

Mr. Bigley stated that he could meet him there to at any time look at it with him to show you what he is talking about. Just I know what direction to go to get it handled for him.

Mr. Daley said ok. I will give you a call.

Mr. Bigley said Thanks Tim!
