The Regular Meeting of the Council of the City of Struthers, Ohio, was held on Wednesday, March 25, 2020 at 7:00 p.m. in Council Chambers with the following members present at Roll Call: Baluck, Bayus, Bigley, Burnside, Carcelli, Greenwood, Pingley.

President of Council, Joseph N. Rudzik was present at the Meeting.

Executive Order

**Declaration of State of Emergency
City of Struthers, Ohio**

WHEREAS, COVID-19 is a respiratory disease that can result in serious illness or death and is caused by the SARS-CoV-2 virus, which is a new strain of coronavirus that had not previously identified in humans and can easily spread from person to person. The virus is spread between individuals who are in close contact with each other, generally within six (6) feet, through respiratory droplets produced when an infected person coughs or sneezes. It may be possible that individuals can get COVID-19 by touching a surface or object that has the virus on it and then touching their own mouths, nose, or eyes;

WHEREAS, on January 30, 2020, the International Health Regulations Emergency Committee of the World Health Organization declared the outbreak of COVID-19 a public health emergency of international concern;

WHEREAS, on January 31, 2020, Alex M. Azar, II, Secretary of Health and Human Services, determined and declared a public health emergency;

WHEREAS, on February 1, 2020, the Ohio Department of Health issued a statewide Health Alert Network to provide local health departments with updated guidance for COVID-19;

WHEREAS, on March 9, 2020, Governor Mike DeWine issued Executive Order 2020-01D declaring a state of emergency for the entire the State to protect the well-being of the citizens of Ohio from the dangerous effects of COVID-19 and to assist in protecting the lives, safety, and health of the citizens of Ohio;

WHEREAS, on March 11, 2020, the World Health Organization officially declared COVID-19 to be a global “pandemic” requiring “urgent and aggressive action” to control the spread of the virus;

WHEREAS, on March 12, 2020, Governor DeWine announced the closing of all kindergarten through 12th grade schools through April 3, 2020 and the Ohio Department of Health Director, Amy Acton, signed an order prohibiting mass gatherings in the State of Ohio;

WHEREAS, on March 13, 2020, President Donald J. Trump declared a National Emergency, invoking the Stafford Act and allowing Federal Emergency Management Agency to coordinate disaster response and aid state and local governments in addressing the COVID-19 pandemic;

WHEREAS, on March 13, 2020, the Department of Health issued an amended Director's Order to Limit Access to Ohio Nursing Homes and Similar Facilities;

WHEREAS, on March 14, 2020, the Department of Health issued an amended Director's Order to require health screening for admission to State operated psychiatric hospitals and Ohio Department of Youth Services facilities and issued a Director's Order closing all K-12 schools in Ohio;

WHEREAS, on March 15, 2020, the Department of Health issued a Director's Order to restrict the sale of alcohol, food, and all other beverages to carry-out sales and

delivery only and issued interim guidance limiting mass gatherings to no more than 50 people;

WHEREAS, on March 16, 2020, the Department of Health issued a Director's Order closing all polling locations on March 17, 2020 in the State of Ohio;

WHEREAS, on March 22, 2020, the Department of Health issued a Director's Order requiring all persons to stay at home unless engaged in essential work or activity;

WHEREAS, as of March 24, 2020, the Centers for Disease Control and Prevention ("CDC") lists 44,183 cases, and 544 deaths, in the United States;

WHEREAS, as of March 24, 2020, the Ohio Department of Health lists 564 cases, and 8 deaths, in the State of Ohio;

WHEREAS, as of March 24, 2020, Mahoning County has 23 confirmed cases and is currently experiencing "community spread" of the virus that causes COVID-19;

WHEREAS, in the City of Struthers, this threat has already impacted the daily lives of the citizens of the City of Struthers, and the need for citizens and City of Struthers employees to stay home from work and other public places should they be exposed to the virus substantially impairs the functioning of city government and its ability to protect the lives and property of the citizens of the City of Struthers;

WHEREAS, § 139.02 of the Codified Ordinances of the City of Struthers creates an Advisory Council of Civil Defense composed of members to be appointed by the Mayor (the "Advisory Council") to advise the Mayor and the Director of Disaster Services on all matters pertaining to civil defense;

WHEREAS, § 139.02 of the Codified Ordinances of the City of Struthers further creates a Director of Disaster Services (the "Director") to be executive head of the Advisory Council and responsible for carrying out the program for civil defense in the City;

WHEREAS, § 139.01 of the Codified Ordinances of the City of Struthers defines "civil defense" as the preparation for and the carrying out of all emergency functions resulting from disaster caused by fire, flood, earthquake or other natural causes, which functions include, without limitation, by reason of enumeration firefighting service, police service, medical and health service, communication, emergency welfare service, emergency transportation, and other functions relating to civilian protection, together with training and all other activities necessary or incidental to the preparation for any carrying out of the foregoing functions;

WHEREAS, § 139.04 of the Codified Ordinances of the City of Struthers provides that, in performing his or her duties under Chapter 139, the Mayor is authorized and empowered to (i) make, amend and rescind the necessary orders, rules and regulations within the limits of the authority conferred upon him or her in Chapter 139, and with due consideration to the plans of the State of Ohio and the federal government, as well as the plans of other political subdivisions for civil defense purposes, (ii) regulate intra-city traffic in the interest of national defense, (iii) make rules and regulations designed to safeguard public health, (iv) enforce all laws and regulations relating to civil defense including federal and state regulations and in emergency to assume direct operational control of all civil defense forces, (v) procure, or cause to be procured, supplies and equipment to institute, or cause to be instituted, training programs and public information programs to insure the furnishing of adequately trained and equipped forces of civil defense and to plan for the most efficient emergency use thereof, (vi) make, or cause to be made, such studies and surveys of the industries, resources and surrounding political subdivisions as may be necessary to ascertain the capabilities of the City for civil defense and to plan for the most efficient emergency use thereof, (vii) delegate any administrative authority vested in him or her under Chapter 139, and (viii) declare by proclamation or executive order a state of emergency;

WHEREAS, I have appointed Christina Bohl, Dallas Bigley, Tim Daley and Tina M. Smith, PA-C as members of my Advisory Council and John N. Zomoida, Jr. as the Director of the Advisory Council; and

WHEREAS, although the State orders currently require all non-essential businesses to close and residents to generally stay home, local governments have an obligation to its residents to continue sustained efforts to minimize the spread and mitigate the effects of COVID-19.

NOW, THEREFORE, I, Catherine Miller, Mayor of the City of Struthers, by virtue of the authority vested in me by the Ohio Constitution, the Ohio Revised Code and Codified Ordinances for the City of Struthers, do hereby order and direct that:

1. A State of Emergency is declared for the entire City of Struthers to protect the lives and well-being of the citizens of the City as well as those who work, attend school, and visit the City, from the dangerous effects of COVID-19.

2. In order to protect the public health, safety, and welfare, including the mitigation of the spread of COVID-19, a curfew shall be established within the corporate limits of the City of Struthers. The curfew shall commence on March 26, 2020 and continue until further notice between the hours of 11:30 p.m. and 5:00 a.m. No person shall be outside in this area during the curfew hours either as a pedestrian or by means of a vehicle, unless such person is (i) providing police, fire, or other governmental services, (ii) participating in, going to, or returning from employment at an essential business located outside of the corporate limits of the City of Struthers, or (iii) experiencing a personal or family medical emergency. This curfew applies to all persons within the corporate limits of the City of Struthers, including businesses located within the corporate limits of the City of Struthers and those traveling through the City of Struthers.

3. This Executive Order shall take effect immediately and remain in full force and effect until (i) the pandemic no longer exists, (ii) such time to be determined by the Governor of the State of Ohio, as determined by the Director of Health of the State of Ohio and/or Executive Director of the Emergency Management Agency of the State of Ohio, (iii) Council, by resolution or ordinance, sooner declares the termination of the state of emergency.

This order shall be in full force and effect after my signature is affixed to this document.

IN WITNESS WHEREOF, I have hereunto set my hand and caused the Great Seal of the Mayor of the City of Struthers, Ohio, to be hereto affixed on this 26th day of March, 2020.

Food Distribution

City Curfew

To further enforce Governor Mike DeWine's Stay-At-Home order, I declared a State of Emergency for the entire City of Struthers to protect the lives and well-being of the citizens of the City as well as those who work, attend school, and visit the City, from the dangerous effects of COVID-19. In order to protect the public health, safety, and welfare, including the mitigation of the spread of COVID-19, a curfew shall be established within the corporate limits of the City of Struthers. The curfew commenced on March 26, 2020 and will continue until further notice between the hours of 11:30 p.m. and 5:00 a.m. No person shall be outside in this area during the curfew hours either as a pedestrian or by means of a vehicle, unless such person is providing police, fire, or other governmental services, participating in, going to, or returning from employment at an essential business located outside of the corporate limits of the City of Struthers, or experiencing a personal or family medical emergency. This curfew applies to all persons within the corporate limits of the City of Struthers, including businesses located within the corporate limits of the City of Struthers and those traveling through the City of Struthers. The Executive Order shall take effect immediately and remain in full force and effect until the pandemic no longer exists. The city would like to acknowledge the businesses who are cooperating with the city during this time and for helping us further enforce the curfew by altering your hours to further protect our city: Dunkin Donuts, Circle K, Sami Quick Stop, One Stop Depot, Morgan Oil, Wildcat Drive Thru, Nemenz IGA and Astro Shapes.

Taxes

We also have decided to extend our local Struthers filing date to July 15th to stay in line with the federal extension. The department will not be accepting any in-person filings. Instead, anyone wishing to file, and or pay their taxes, may do so by dropping them off in the drop box located in the door by the police garage marked "DROP OFF" where we have tight surveillance in place. They will mail receipts if necessary. There are also forms on our website if needed at www.cityofstruthers.com under the tax department tab.

Senior Van

We did temporarily suspend the Struthers Senior Van transportation services for the time being. We are working in collaboration with a quick action group that began with the help of our very own, Kristen Olmi. This group has been organized to provide seniors with assistance during COVID-19. They "have volunteers who will pick up food items from the grocery stores or food banks, medications from pharmacies, and deliver them to your home. Volunteers will also provide transportation to/from medical appointments." Please dial 330-530-4038 ext 222.

UNFINISHED BUSINESS (On Audio)

Mr. Richard Bayus stated that he could barely hear what was said about the raises for the Police Department. This question is for the Auditor and Mayor. Were these raises already budgeted in this Budget should they get passed after said Covid-19. Thank you I was unable to hear.

Mrs. Christina Bohl, Auditor, answered that they are in fact already in place in the Budget that was anticipated it would cost for said raises that were agreed upon but not signed into a contract yet. She stated that if you all recall during the Budget workshop that these numbers are based on estimated receipts that were known at the time the Budget was created and obviously things have changed in the last weeks. Like Council suggested this Budget will likely be revisited as early as 30 to 45 days and those numbers my change. As you all know that we need to have a Budget in place by March 31, 2020 to operate the City. This is a good Budget based on the information we had and to answer your question: yes these Budget does include the raises that were discussed but not signed into contract yet.

NEW BUSINESS

There were no remarks or comments under New Business.

REPORT OF LAW DIRECTOR (On Audio)

Law Director, John N. Zomoida, Jr. was present at the meeting and had no said report for Council this evening. Mr. Zomoida spoke to the enforcement of the Executive Order and the protection for the residents of the City of Struthers at length. Mr. Zomoida explained that he was going to send off a letter to the Police Chief on how to go about enforcing the order. He went on to say that there will be actions of the order 1) Verbal warning for 1ST OFFENCE, 2) Attention of the Law Director 2ND OFFENCE and 3) 3RD OFFENCE Summons of Obstruction if people choose to violate the Executive order 3xs or more.

There were no remarks or comments for the Law Director.

REPORT OF AUDITOR (On Audio)

Auditor Christina Bohl was present at the meeting and had no said report for Council this evening.

REPORT OF SAFETY SERVICE DIRECTOR

Safety Service Director was present at the meeting and had no report for Council this evening.

Remarks/Comments:

Mr. Ronald A. Carcelli asked the constituents that are turning in complaints in are these being placed on hold until all is back to normal or what?

Mr. Daley stated that yes. All complaints will go on hold until we get back to the office.

Mr. Ronald A. Carcelli said ok, thank you!

President of Council asked if it would help to put that information of the Executive Order on the electric sign downtown.

Mr. Daley said that yes we could do that. I would have to talk to Michelle but that should not be a problem.

ADDRESSING OF COUNCIL (On Audio)

(On Audio - These minutes are a summarization of the Regular Meeting and not verbatim.)

Ms. Michelle Douglas, 265 Oakview, Struthers, Ohio 44471. I want me and my Family will be in complete compliance of the executive order: 10:30 p.m. until 5:00 a.m.

Mr. Zomoida stated 11:30 p.m. until 5:00 a.m.

Elaine Ginnetti, 9th Street, Struthers, Ohio 44471. She first started off thanking the Mayor, John, Council and Megan for bringing the meetings into our homes. I have a question for Chrissy about the Budget was drastically cut. She wanted to know if the City will be able to run efficiently due to all the cuts and those cuts were made before COVID-19. What is the reason?

Auditor Bohl stated that there is a two part answer to her question. The first part would be the reality of what light was when this Budget was put into place and the second part would be what the reality is now. Chrissy stated that the City had about \$500,000.00 less unencumbered balance which means that that much less to Budget with so what we normally do is we anticipate the receipts that are coming in and add it to money that were not appropriated the year before and we come up with a total and we use that total for a Budget and get that total certified through the county and not pass a Budget that exceed that total. She stated that she is limited to what can be budgeted due to the money that we will have available. So she stated that she spreaded that total

decrease around the Budget. People are going to have to tighten the Budget. She spoke at length on the matter.

Elaine wanted to know why we are so far behind on collecting money?

Auditor Bohl stated that we collected \$400,000.00 less in income taxes in the year 2019 then we took in in the year 2018. So with the collections in 2019 were for collection in tax year 2018 is why the Budget is significantly less than year prior. Tax collections down coupled with equipment needed for the City to operate. We simply have less money.

Elaine with the COVID-19 would Federal and State money be available to the City of Struthers.

Remarks/Comment:

Mayor Cat Cercone Miller stated that she believed that it will that is what our Legislators are working on to become available to the City and that is why we had to declare our City in the State of Emergency so that we can be considered for State and Federal Funds because if we didn't declare then we would not be eligible for grants moving forward. I am sure funding will be available but not sure what at this time.

Mr. Dallas A. Bigley wanted to make a point off of what Elaine had to say, He stated that 75% of our City income comes from Income Tax so when you put that into perspective the residual comes from this will come next year. That is when we are really going to have to tighten up and we are going to be in trouble. Everyone's income tax is going to be down this year because you are missing months of work. We are missing revenue from the Businesses that we get tax revenue from so next year I am going to be very concerned with moving forward so we are going to have to be prudent as possible with spending this year, next year and possibly the following year after that.
