**AN ORDINANCE FOR THE APPROPRIATION FOR CURRENT
EXPENSES AND OTHER EXPENDITURES OF THE CITY OF
STRUTHERS, STATE OF OHIO, COVERING THE FISCAL YEAR OF
2014 ENDING DECEMBER 31, 2014 AND REPEALING ORDINANCE
NO.13-043 AND ANY ORDINANCE INCONSISTENT HEREWITH
AND DECLARING AN EMERGENCY.**

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of Struthers, Ohio, ³/₄'s of all members elected thereto concurring:

SECTION 16: That the City Auditor is hereby authorized to draw her warrants on the City Treasury for payments of any of the foregoing appropriations upon receiving proper certification and vouchers thereof, approved by the Board of Officers authorized by law to approve the same or an ordinance or resolution of Council to make expenditures; provided that no warrant shall be drawn or paid for salaries or wages, except to persons employed by authority of an in accordance with law or ordinance.

The appropriation for contingencies shall only be expended upon the approval of three-fourth's (3/4's) of Council of items and expense constituting a legal obligation against the City and for no purpose other than those covered by specific appropriations made herein.

SECTION 17: That Ordinance No. 13-043 and any ordinance inconsistent herewith is hereby repealed.

SECTION 18: This Ordinance is hereby declared to be an emergency measure necessary for the preservation of public peace, health and safety of the inhabitants of the City of Struthers, Ohio. Said emergency exists by reason of the fact that payrolls, city obligations and financial expenditures must be paid, and, as such, this ordinance shall take effect immediately upon its passage and approval by the Mayor.
